## Definitions:

The 'College' means EyebrowExperts, trading as 'EyebrowExperts'.

The 'Student' means the signatory of this form and their parent or guardian in the case that the Student is under 18 years of age. The 'Course' means the course/s selected on the enrolment form.

## Terms and Conditions of Enrolment:

The balance of the course fee is due upon booking to secure your place. Payment can be made by Cash, Eftpos, Credit Card or Electronic Funds Transfer.

Payment plans are available by request for all courses. Please contact the college for a separate 'Payment Plan' form. Payment plans incur a 10% percentage charge on top of the standard course fees to cover setup fees, transaction fees and administration costs.

Cancellations and course transfers will not be accepted unless the student notifies the College at least 14 days prior to the course start date, and the full course fees will still be due and payable. EyebrowExperts often has waiting lists for courses, and unless the student notifies the college of their desire to cancel or transfer at least 14 days prior to course commencement, the remainder of the full course fees will be due and payable.

To comply with the privacy act in all respects, the person signing this document acknowledges that all information contained in this document and all other documents given to the college pertaining to the same signatory of this document or their agent, may be given to a third party for the exclusive purpose of debt collection. This information may also be shared with a Credit Reporting Agency for the purpose of creating or maintaining an information file on the student.
